CALIFORNIA AUTHORITY OF RACING FAIRS Board of Directors & Live Racing Committee Concurrent Meeting Tuesday, September 1, 2020

MINUTES

A concurrent meeting of the California Authority of Racing Fairs (CARF) Board of Directors and Live Racing Committee was held at 11:00 A.M., Tuesday, September 1, 2020. The meeting was conducted via teleconference originating at the CARF office, 1776 Tribute Road, Sacramento, CA, 95815.

CARF Board Directors joining by conference call: John Alkire, Jerome Hoban, Dan Jacobs, Rick Pickering, Dana Stoehr and Kelly Violini.

CARF Live Racing Committee members joining by conference call: John Alkire, Jerome Hoban and Rick Pickering.

Agenda Item 1 – Date, Time and Location of Next Meeting: The next CARF Board of Directors and Live Racing Committee meeting will be held at 11:00 a.m. October 6, 2020 by teleconference originating in Sacramento.

Agenda Item 2 – Public Comment. John Brown, legal counsel for the Arabian Horse Racing Association, stated he would like more information regarding the 2020 Big Fresno Fair race meet. Mr. Swartzlander noted that this topic would be covered under Agenda Item VIII.

Mr. Alkire reported to the Board that he is in the process of retiring from the Big Fresno Fair and has accepted the position of CEO of the Friends of the Fair, a 501(c)(3) in partnership with the Big Fresno Fair. Mr. Alkire will be succeeded by Lauri King and Stacy Rianda. He introduced Ms. King as the racing representative for the Big Fresno Fair and was thanked for his many years of service to the fair and horse racing industry.

Mr. Alkire recommended that Mr. Hoban chair the remainder of the meeting until an agenda item can be made to allow a formal vote by the Board.

Agenda Item 3 – Closed Session: Conference with Legal Counsel – Personnel. Ms. Grottveit reported that during closed session the Board had conference with legal counsel and received advice regarding personnel. No action was taken.

Agenda Item 4 – Approval of Minutes. {ACTION} Mr. Alkire moved to approve the CARF Board of Directors & Live Racing Committee concurrent meeting minutes for June 2, 2020 as presented. Mr. Pickering seconded, unanimously approved.

Agenda Item 5 – Report, Discussion and Action, if any, on Legislative Program. Mr. Brown reported that the legislative session ended the night before thereby ending the legislative year. The Governor has seen a lower number of bills cross his desk due to the challenges and focus on COVID-19.

AB 1974, which supports jockey and equine safety reform, was run by the Assembly GO Committee and the chair of the GO, Senator Adam Gray, acknowledged the fairs excellent record regarding breakdowns and track safety and maintenance. Passing both houses with bipartisan support, Mr. Brown fully expects the bill to be signed.

Governor Newsom appointed new member Brenda Davis to the CHRB Board. Ms. Davis is a former attorney with the Farm Bureau and is currently in private practice with no prior ties to horse racing. Both CHRB commissioners Wendy Mitchell and Oscar Gonzales were reappointed for another 4 years. Mr. Pickering and Ms. Stoehr reported positively regarding fair industry interactions with Ms. Davis and believe she will bring a welcomed perspective to the CHRB Board.

Mr. Brown reported that \$5 million in AB 1499 funds were withheld for infrastructure purposes in the fairs network, but due to COVID-19 the monies from both 2019 and 2020 have been merged to a total \$12 million. Mr. Brown expects CDFA to true up allocations and taxes for each fair and aim for a hopeful disbursement of these monies to the fairs by early next year.

Mr. Brown noted that newly released information from the Governor's office includes reopening procedures for satellite wagering in stages. He plans to give an update after his office has reviewed the new information – hopefully, satellite wagering will move indoors with limited operations.

Sports Wagering has eluded the November ballot for a second year. Mr. Brown added that legislative members would resume talks and aim for a 2021 Sports Wagering initiative.

Agenda Item 6 – Report and Discussion on Finance Committee Recommendations. Mr. Swartzlander reported that there were three objectives of the Finance Committee:

Re-analyzing CARF Racing Overhead Costs: Mr. Swartzlander stated that due to COVID-19 and the fluid situation with race dates, that CARF racing overhead costs will have to be redistributed to reflect what the actual 2020 race calendar was as opposed to the projected calendar.

CARF Restructuring of Personnel: Mr. Swartzlander noted that personnel discussions were held in closed session. **{ACTION}** Mr. Hoban moved to direct the Executive Director to reduce payroll costs by \$87,000 in the remaining months of 2020 and 2021 to reduce overhead costs in light of racing calendar changes created by the COVID-19 pandemic.

Mr. Pickering seconded and thanked Mr. Swartzlander and staff for accepting these cuts when many in the industry are receiving similar reductions. Motion was unanimously approved.

CARF Dues: Mr. Swartzlander reported that upon the onset of the COVID-19 pandemic, CARF stopped invoicing member fairs for dues. With a successful meet at the Alameda County Fair, ADW location fees were 40-50% higher than normal. This is mind, the Finance Committee recommended that the CARF agency net ADW location fees with dues owed for 2020.

Mr. Swartzlander asked for any objection by members on the call, hearing none, Mr. Swartzlander added that checks would be disbursed the following week.

Agenda Item 6 – Financials. Ms. Gibbons reported that she is in the middle of closing numbers on the Alameda County Fair meet. With the Gilbert audit now finished and in draft form, Ms. Gibbons added that Gilbert will plan to present their report to the Board in October.

In financial consideration, Mr. Hoban directed Ms. Gibbons to investigate if formal reviews between audits can be done to save money. Ms. Gibbons recommended that staff review this with legal as it pertains to CARF's JPA agreement. If allowed, this could be a possibility in 2021 for the 2020 review.

Agenda Item 7 – Report, Discussion and Action, if any, on Racing Calendar and Live Racing Operations. Mr. Swartzlander reported that there was a Racing Dates Committee meeting with Commissioner Oscar Gonzales serving as chair. Dates presented to the committee are similar to 2020's proposed calendar before COVID-19. Mr. Swartzlander noted that past issues with Sonoma County Fair's race dates and stabling at Golden Gate Fields were once again brought up at the meeting.

Mr. Swartzlander asked Mr. Margetts from Sonoma County Fair if they are planning to run their race dates at Golden Gate Fields in 2021. Mr. Margetts reported that it is unknown at this time due to the complications with COVID-19.

Regarding the 2020 Big Fresno Fair meet, Mr. Swartzlander reported that Golden Gate Fields has signed an agreement to run these dates in exchange for financial and purse relief. Mr. Swartzlander reported that Mr. Alkire expressed desire to run the race dates at Fresno, but in consideration of complications created by COVID-19 and in keeping the best interest of horsemen in the forefront, Mr. Alkire agreed to this one-time arrangement. Mr. Swartzlander addressed the Arabian breed representatives on the call that these race dates are under the control of the Golden Gate Fields racing license and that CARF cannot dictate the type of races run.

Agenda Item 9 – Executive Director's Report. Mr. Pickering asked for an election to be scheduled for chair and vice-char of the Board of Directors and Live Racing Committees. Mr. Pickering included his thanks and congratulations to Mr. Alkire for his years of service and welcomed Ms. King and Ms. Rianda in their new positions.

House panel approves bill to combat doping in horse racing

WASHINGTON — A key House committee on Wednesday gave bipartisan approval to legislation to create national standards for the horse racing industry to prevent fatalities and discourage illegal medication practices. The Senate's top Republican said he would press to pass the bill before the year is out.

The 46-5 vote in a Democratic-controlled panel is a good sign for the bill's prospects.

"Our bill delivers commonsense medication and track safety standards that protect America's horses and jockeys, needed progress that will put this popular and historic sport on track for a strong recovery and a bright future," said top sponsor Paul Tonko, D-N.Y., whose district is home to Saratoga Race Course, a premier racetrack.

Senate Majority Leader Mitch McConnell, R-Ky., whose state is home to the country's top breeding outfits and the Kentucky Derby, introduced identical legislation with senior

Democrats from California and New York, which also have top racetracks and breeding operations.

The "Horseracing Integrity and Safety Act" comes after the racing industry has been hit by a series of doping scandals and a rash of fatal breakdowns in recent years. It is also struggling through the COVID-19 pandemic, with tracks like Churchill Downs holding races – including last weekend's Kentucky Derby, delayed from May – without spectators.

Several top trainers were charged earlier this year with illegally doping their horses with performance-enhancing drugs, including Jason Servis, whose horse Maximum Security finished first in the 2019 Derby but was disqualified for racing interference.

The legislation is aimed at empowering an independent Horseracing Integrity and Safety Authority with federal recognition and enforcement power to set uniform standards for medication, track safety, and testing of horses for PEDs.

"Unfortunately, the coronavirus isn't thoroughbred racing's only challenge. In recent years, tragedies on the track, medication scandals and an inconsistent patchwork of regulations have cast clouds over the future," McConnell said in a floor speech.

While blue-blood racing organizations such as the Jockey Club and key racing circuits support the idea, McConnell has not attracted cosponsors from states like Florida, Louisiana and New Jersey, where some of the sport's scandals have occurred and where oversight is considered uneven at best. But Frank Pallone, D-N.J., chairman of the powerful Energy and Commerce panel, is a strong supporter.

McConnell said in a brief hallway interview that the industry has long been plagued by disunity and that after reading a Washington Post editorial questioning whether racing should remain legal he told stakeholders "in the strongest possible way that they needed to get together or I would try to do it for them. And they did get together."

McConnell said he hopes to win passage of the legislation before the end of the congressional session and plans to discuss the topic with House Speaker Nancy Pelosi, D-Calif.

Also at issue is a series of horse fatalities in California in recent years, which has garnered the industry bad press and enemies like People for the Ethical Treatment of Animals.

The legislation faces challenges in the Senate, given the time crunch and potential opposition. But McConnell said he would press the issue in a post-election lame duck session.

The legislation faces an uphill road in the Senate, given the time crunch and potential opposition, but it sends a signal that lawmakers may tackle the issue next year. A companion House bill has sufficient cosponsors to demonstrate it would pass but it has not been slated for a vote.





Pari-mutuel, translated from its French origin, literally means "wagering amongst ourselves."

Simple, fair scoring methods

- Athletes points are developed using obvious achievement objectives from their respective sports
- Football example:
 - Quarterbacks, Running Backs and Receivers earn one point for each positive yard gained passing, rushing, or receiving.
 - 5 Bonus points for scored points, example: 30 points for a 6-point scored touchdown.
 - Refunds from "scratches" if a selected athlete does not appear during any segment of the live game. This obvious fairness in scoring is not offered with the major fantasy sports providers.
 - "Alternate" selections can be made in advance for replacement of scratched athletes





"In sum, as the proposed fantasy sports game is not won or lost based on a winning outcome from any real sports team or single performance of an individual athlete, but on the accumulated statistical point totals developed by individual contestants competing against each other, based on their knowledge and skill, the game is not the conduct of gambling or wagering under accepted definitions in most state and federal laws."

"...the proposed fantasy sports contest is not a lottery or sweepstakes, and is not a betting, gambling or wagering scheme. As the proposal involves contests of skill among players competing in the game, it is not any of the activity contemplated by PASPA."







"Roxy" Roxborough Director

Michael "Roxy" Roxborough is an American odds maker, syndicated columnist, teacher and author. He is best known as founder and owner of Las Vegas Sports Consultants, the international odds making company licensed by the Nevada Gaming Control Board. Roxborough is credited with introducing mathematical formulas and computer models to the multi-billion-dollar sports wagering industry. The Las Vegas Review-Journal listed Roxborough number two in its list of the most influential people in sports of the 20th century. The well know sports betting personality was elected to the Sports Betting Hall of Fame, Class of 2020.

Roxborough was a co-founder of American Wagering Inc, the first U.S. bookmaking company to be listed on a public stock exchange in 1996 (Nasdaq: BETM). He served as a director from the company's inception until March 11, 1998. The company was subsequently purchased by UK Bookmakers William Hill PLC.

"Roxy" also co-founded "America's Line," a daily newspaper sports odds column syndicated by Universal Press in 1988 appearing in more than 120 North American newspapers.

Roxborough and Mike Rhoden co-authored "Sports Book Management: A Guide to the Legal Bookmaker", originally published in 1988 and updated in 1991 and 1998. The 112-page book served as text for the college course Race and Sports Book Management taught at the College of Southern Nevada (formerly Clark County Community College) as part of the Casino Management curriculum.



Pari-mutuel Fantasy Sports



Unlike "house" banked games or the use of salary caps, pari-mutuel systems allow fantasy sports contestants to determine pricing and freedom to play contests according to their expertise: from easy to difficult.

We believe the efficiency inherent with pari-mutuel systems, the original "skilled selection" platform is best suited for Daily Fantasy Sports (DFS) contestants for the following reasons:

- 1. EASIER SELECTION PROCESS: Greatly reduces field sizes allowing for more accurate, skilled and time saving selections. DFS operators typically offer selections of no less than twice the total athletes that will perform in each category, including injured or non-active athletes!
- 2. SIMPLICITY THROUGH PROVEN TECHNOLOGY: GSFS requires a minimum of a single selection from a field of less than 20 athletes. Comparatively, the time-consuming process of typical DFS roster selection requiring no less than 5, more typically 9, individual selections from full rosters of sports teams and easily take up to 15 minutes per transaction.
- 3. MORE SKILLFUL, STRAIGHTFORWARD GRADING: Contest grading is based on far fewer variables than current DFS standards. Typical DFS grading sets dozens of statistical performance elements using addition, subtraction and fractional numbers. The GSFS model grades on the most obvious athletic performance result using simple additions and subtractions and keeping scoring determinants to a minimum. While DFS complexity caters to statisticians and modelers, GSFS targets casual sports fans allowing contestants to enter at their chosen skill level.
- 4. CONTESTANT-DETERMINED PRICING: Contestants determine the athletes' values through the "auction" inherent in the pari-mutuel systems. Typical DFS platforms assign "handicaps" on the athletes with using varied salary values, much like point spreads in sports betting. The assigned salaries in today's DFS does not change, regardless of disproportion of entry fees creating sensitive "insider" information. Pari-mutuels provides a skillful, transparent system allowing contestants to observe and set the athlete pricing through the open entry fee selection process.
- 5. CONTEST FAIRNESS-SCRATCHES: Sporting events, primarily baseball, postpone regularly due to inclement weather. Roster selections from canceled games provide assure a loss for the contestant. While all contestants have the same potential handicap, it clearly disadvantages those unable to adjust prior to game time. Additionally, all sports render athletes inactive through in-season trades, coaches' decision, injuries and demotion. GSFS allows for scratches, refunds and/or alternative selections under these circumstances.
- 6. "SHARKS VERSUS MINNOWS" INEQUITY SOLVED: DFS is plagued with unequal win from a small percentage of contestants using computer assisted play (scripting). Additionally, the "insider" information scenarios have not been adequately solved. Results of computer-assisted contestants prove impressive and support the "skilled contest" debate. However, advantaged contestants flood contests with computer assisted roster selection and multiple entries, surreptitiously fleecing casual, less advantaged contestants. Efforts to discourage this practice have unreliable results. Pari-mutuel systems mitigate disproportionate entries through the pooled "auction," automatically providing pricing adjustment for unbalanced entry on individual athletes. The transparency provided through visible, consistently updated, pari-mutuel athlete pricing eliminates "insider trading" concerns.



Fan feedback : "9 reasons GSFS is best"

1) **The scoring system is very simple.** One of the biggest complaints about certain forms of DFS is the scoring can get to be a bit cumbersome with varying levels of points per reception or 1.2 points for rebounds. GSF gets rid of all of that and keeps things straightforward with everything being worth either a whole number or half number. There is never going to be a score of 87.34 in US Fantasy. Fractional scoring like that can be daunting. In Golden State Fantasy Sports (GSFS)if a player rushes for 67 yards, he gets 67 points. Simple and fair.

2) **There is 100% transparency on "ownership" levels.** If you're not familiar with how a pari-mutuel system works, don't worry, GSFS is going to get you the education. What's important to understand is that GSFS puts right on their website how much money has been wagered on all their different types of bets in each prop. Do you want to know how much has been wagered on Kevin Durant to SHOW? Great, it's right there. How much is in that SHOW pool? It's there as well. This information can help savvy DFS players like yourself find the best bets to hit the biggest payouts. With that level of transparency, you can easily see who the public likes, thus setting up your contrarian plays to hit the big money (something us DFS players love to do).

3) Your sleeper plays will pay off if you're right. There's nothing worse than hitting on a big sleeper of in traditional DFS only to have the rest of your lineup be hot garbage. If there's a player you like flying under the radar, like Jay Ajayi in Week 16, you can bet him in a number of different ways (WIN, PLACE, SHOW, or as part of an exotic like an exacta) to take advantage of his long odds (low ownership in DFS lingo). If Ajayi scores the way you think he will, you win money. That doesn't happen in traditional DFS unless you've surrounded Ajayi with all the right players. One player in traditional DFS can't lead to a cash, where in GSFS it's an easy way to cash.

4) **You play who you want to play.** There's no salary cap to worry about in US Fantasy. If you want to play Sidney Crosby every night, you can do that without having to take a hit elsewhere in your lineup because there is no lineup to worry about. When Crosby hits, you win. It is very frustrating for a casual sports fan to want to put together a traditional DFS lineup but be unable to fit in all the players they want to root for under that salary cap. That's not an issue at all at with GSFS. You can bet whomever you like in a variety of ways.

5) **If you are a traditional DFS player, your skills WILL translate.** One of the most time-tested ways to win a GPP in traditional DFS is to hit on your contrarian plays, guys that go low owned but pop off for big games. This skill translates incredibly well to GSFS. Go back to any of the previous games in any of the sports and you'll find players with long odds in the top 3 scorers. In Week 16 of the NFL those guys were Aaron Rodgers in Prop 1, Jay Ajay/David Johnson in Prop 3, and the list goes on. Without having to guess who the "chalk" plays are, you can use your unique set of skills to take full advantage of groupthink and pound the contrarian plays.

6) Late inactives won't kill you. What's worse than loading up a DFS lineup only to find one your key players was scratched before the game. When the rest of your team hits and you're sitting with that one zero, you want to throw your computer out the window. Not only did you miss a potentially big payday, but you also lose your entry fee. That's not the case with GSFS. If a player gets scratched, bring your ticket back to the window after the games and you get your money back. Yes, it still stings to not hit your big trifecta but at least you don't suffer the indignity of losing your entry as well.

7) **Cash game.** Depositing and withdrawing money from traditional DFS sites is rarely a fun experience and sometimes can be downright frustrating. Here, you can walk to a teller window to enter the contests, then walk back to the window to cash your ticket. There's no waiting. DFS players love our immediate gratification and there are few things more gratifying than having cash in hand as soon as the results of that day's action is posted.

8) **Multiple people can hit a big payout.** One of the worst things about traditional DFS is the payout structures are top heavy. If you don't hit one of the top 3 spots in a GPP, you don't win the big money. That's not true here. If you play the right combination of players, you win the same amount of money as everyone else. Everyone who had an Aaron Rodgers/Andrew Luck exacta in Prop 1 in Week 16 got paid 150-1 (\$300 on a \$2 exacta). No, that's not the same as winning a Milly Maker (though Million Dollar payouts can happen) but if you put \$20 on that exacta, you won \$3,000. In order to win that much in a traditional DFS tournament you'd have to beat out hundreds of thousands of other lineups.

9) **You're playing for yourself.** - One of the biggest complaints about traditional DFS is people with the most money win the most tournaments because they can enter the most lineups. No lineups required with GSFS. If you pick the player that wins his field you win money, regardless of who anyone else plays. There's something very satisfying and equitable about a game where you get paid for being right and not having to worry about being "more right" than anyone else.
